Dance Director's Report

Happy 2020 Everyone!

I hope you have at least one resolution to dance more in 2020!

Our schedule is a bit different in the early part of the year. We'll check out a new venue (needed due to lack of availability at Lincolnia and Accotink Church). Our first dance will be at Galilee Church in Sterling. This is where Bernie and Lydia teach lessons each week, so we hope some of their folks will find their way to us. After that, we'll be at Lincolnia for one dance, then at Accotink for a dance, and then back at Lincolnia for most of the year. There are a couple of other changes months from now.

Lessons for the first dance will be Basic 2 Step at 6pm with Rich and me teaching. As I suggested above, we hope to have a few new people. If not, I can whip up a more difficult lessons pretty quickly, since I teach 2 Step every Friday at Nick's. At 6:30, Bernard will teach "Honky Tonk Highway", which he taught last year, but hasn't been done much.

Otherwise, I'm working on lining up some lessons with our faithful volunteer instructors. As always, I'm looking for some new 'blood' in that department, especially for couples' lessons. I'm sure it's a daunting idea for many of you, but once you get over the first time, you'll find it's easier than you think, especially if you teach something you know well. I'm always willing to let you teach me first, if you want before you teach a whole group.

While I'm thinking about it, we could use a few more couples' dancers too. Please remember, that there is nothing wrong with ladies learning the lead part or guys learning the follow part.

It keeps you on your toes and helps when there are not sufficient partners of one side or the other. That was part of my motivation for learning to lead a long time ago. Now, I dance either the lead or the follow part, so I can choose more people as dance partners. It also helps people who usually lead to learn what the follower needs, and it gives the usual followers an appreciation for how difficult leading can be. Bottom line: when we teach a couples' dance, get up and learn one part or the other. It will help your overall dancing.

Our demo team is busy getting ready for some events later in the Spring. Dates are being booked. Practices will be happening soon, I'm sure. Please consider joining in the fun. You don't need to know every dance the team does. You can line dance, couples' dance, or do both. We do dances that are taught and danced at regular dances. In fact, I will likely have some of the list of dances taught at upcoming dances, just so more people might be comfortable doing them. Some of our events are demo only. Some are demo and teaching. It all depends on what is asked of us. You don't need to commit to every event, but we need enough dancers at each to make a good showing. Our mission is to take the fun we have dancing to the community. We are not perfect we let our audiences know that. We dance to have fun. If you have any interest, see me, Marie-Luce, Kat, or any other team member. Our only stipulation is that you must be a member of NVCWDA in order to participate. So please give it some thought!

I hope you continue to come out and support the Association. If you have suggestions relating to lessons, or want to volunteer to teach something, please let me know.



Virginia Line Dance Festival

For people who enjoy line dancing, the annual Virginia Line Dance Festival in Fredericksburg, VA from August 1-4 had plenty of dancing to be done.

Several people from NVCWDA attended this event, which featured participants and world-class dance instructors from several states.

The festival opened on the evening of August 1 with an open dance, which featured dances from beginner to advanced levels. Demonstrations of dances scheduled to be taught at Friday's workshop were also done that evening.

Friday, August 2, and Saturday, August 3 featured line dance workshops in four different rooms. One room was for ultra-beginners, another room was for high beginner/low intermediate level participants, and two rooms were for intermediate/advanced levels of dance. Participants were free to move to different rooms for the workshops. Three sessions of one hour workshops took place in the morning, and four more workshop sessions were conducted in the afternoon. Dances were taught to all genres of music from country to rap, to rhythm and blues to pop oldies. Some of the dances taught in the workshops were taught by the choreographers themselves.

Friday and Saturday nights featured open dancing in three different rooms. One room played dances tailored to ultrabeginners, another room played high beginners/improver/low intermediate dances, and for those participants who wanted to "up their game," there was a room that played intermediate/advanced dances. Participants were free to move from room to room, and in some cases, dances taught during the daytime workshops were done during the open dance.

Sunday, August 4 featured three more workshop sessions to close the festival. Needless to say, a great time was had by all, and we all went home to rest our bodies after all of the dancing. It was great to see people who I have met over the many years I've been there. If you enjoy line dancing, you might wish to put this on your calendar, (Next year's Virginia Line Dance Festival is scheduled from 30 July – 2 August 2020) but bear in mind, there is generally a minimum amount of country music played at this event.

DISCLAIMERS: Any opinions expressed in this article are solely mine, and do not reflect the opinions of other NVCWDA participants attending the event or NVCWDA itself. I had a previously scheduled commitment on the late afternoon and evening of August 3, and was not present at the event during that timeframe, and my comments were based on previous experience.

Board Meeting Notes

July 20: A loss of \$650 for the last quarter was noted and discussed.

There was a suggestion that Reston Community Center could serve as an additional location for Association dances.

The difficulties of being without an At Large Director were brought up. It was agreed that dance attendees be informed of likely changes in food at the dances if the Association continues without an At Large Director.

There are now 89 members. It was agreed by the Board that membership cards will no longer be given out (the use of membership cards is being phased out).

Hamilton Elementary School, in Loudoun County, now has a line dance program. Bernard will be teaching line dances to the elementary school students under the Association name after school on Mondays (the Association will now be a vendor with the State of Virginia). Bernard may bring some of his students to an Association dance or dances. (note from editor: this program did not reach fruition)

A retractable banner and three yard signs were approved for purchase by the board to advertise the Association at performances and dances.

November 2: Secretary (Jeff) reported that the renewals for the Association with the State Corporation Commission and the Virginia Department of Agriculture and Consumer

Discussions about changing the bylaws to allow for fewer officers. Some opposition to the change was voiced and no vote held.

New Year's Eve dance was discussed. The need for volunteers and someone to coordinate the event was brought up and will be expressed at the dances. Lydia to print the tickets. There is a need for advertising on the internet, in the newsletter, in the Fairfax Connection and on Facebook.

Decision was made to have no January 4, 2020 dance and no July 4, 2020 dance. It is expected there will be a Halloween Dance October 2020.

Next meeting was set for December 21.
